



Terms and Conditions – The Seasonic Legacy Hunt

1. General

The Seasonic Legacy Hunt (“the Campaign”) is organized by Sea Sonic Electronics Co., Ltd. (“Seasonic”). Participation in the Campaign constitutes full acceptance of these Terms and Conditions. This promotion is in no way sponsored, endorsed or administrated by, or associated with, any other entity, than Sea Sonic Electronics Co., Ltd.

2. Campaign Duration

One (1) Seasonic PSU model will be announced as “Wanted” each week. The campaign will continue for multiple weeks as communicated on Seasonic’s official website and channels.

3. Participation and Eligibility

Participation is open worldwide to individuals aged 18 or above. Participants must be the rightful owners of the PSU model featured during the relevant campaign week. Seasonic reserves the right to request proof of purchase or ownership to validate eligibility.

4. How to Participate

Participants must submit the required information and photos of their PSU via the official form provided by Seasonic. The first valid entry that meets all requirements for the “Wanted” PSU of the week will be selected as the Winner. If there was no immediate Winner selected, the entry stays open until it gets fulfilled.

5. Verification and Winner Announcement

Seasonic will verify each entry to confirm ownership and the functional condition of the PSU. Only fully operational units are eligible for Rewards. Winners will be announced within two (2) weeks following the close of each weekly round to allow time for verification. If there was no winner announced, the entry spot stays open until the end of the Campaign period.

6. Shipping and Handling

Participants are responsible for the initial arrangement and cost of shipping their PSU to the nearest designated Seasonic regional office (USA, Germany, China, or Taiwan). Sea Sonic will reimburse the participant for these specific shipping costs only after the parcel has been physically received, verified, and the participant has provided both a valid carrier receipt and a verifiable tracking number.

Seasonic will cover the full cost of shipping of the Reward PSU back to the winner.

Sea Sonic is not responsible for any customs duties, import or export taxes, brokerage fees, or other related charges that may apply when shipping items to or from Sea Sonic’s offices. All such charges remain the sole responsibility of the participant. Seasonic assumes no liability for parcels that are lost, delayed, or damaged during transit to its offices.
